The California Digital Library, as well as the efforts to share common off-site storage for books, has served important system wide functions for the campus libraries, also providing many economies of scale.

The President's Postdoctoral Fellow Program represents one of the most important efforts nationally to increase faculty diversity by supporting a diverse range of postdoctoral students in a very competitive program and creating a pipeline for UC campuses to recruit excellent and diverse faculty.

UC plays an important role in disseminating and coordinating policies for graduate study and research. The Multi-Campus Research Programs and Initiatives have played a major role in leveraging strengths and programs across UC campuses.
